Anyone who plans to dig is required by law to notify the state of their intentions at least 48 hours in advance.

All digging requires the 48-hour notification so that buried telephone line, television cable, pipelines, utility electrical lines, municipal water and sewer lines can be located to ensure that none will be severed or damaged.

Ur 75th anniversary celebration and annual meeting will be behind us by the time you read this, as the *Northern Lights* went to print a couple of weeks in advance of the meeting. I wish I could say more about it, but that will have to wait for our next issue. Thanks to all who participated. I hope you had a good time.

The 75th anniversary celebration was mostly about history. However, during our annual meeting and at a display booth, we rolled out a bit of something to come: "Northern Solar." An 80-kW Direct Current (DC) community solar project was approved by the board at its May 29 meeting. Building the project is contingent on the members subscribing for at least 50 percent of the 192 panels' production output. We are hopeful we can begin construction this fall, but commitment to the project will dictate the construction time frame.

Beltrami Electric members will now have the opportunity to participate in a solar project without the hassle of designing, installing and maintaining systems on their own property. Members who purchase the output of a panel(s) will have the kWh production each month credited to their electric bill at current rates. As rates increase over time, so will the value of the output over the 20-year lease. Members can purchase increments in as little as one-half panel or as much as the equivalent to their lowest monthly electric energy usage with a maximum of six full panels. Maximum purchases for seasonal and commercial accounts will be considered on a case-by-case basis.

We have heard from members who have encouraged Beltrami Electric to move in the direction of offering renewable energy to our membership. In the early 2000s, we began offering wind energy through the Infinity Wind Energy Program. This allows members to purchase blocks of wind energy, at an additional price of \$0.30 per 100 kWh block, applied directly to their electric billing. The Infinity Wind turbines are located in Petersburg and Valley City, N.D. A member who wishes to subscribe to the Infinity Wind Energy Program, or increase their current subscription, may contact our office. Today's model is different as we heard from the interested members that they wanted the facilities located in Beltrami Electric's service area. Solar is more fitting in our service area than wind, frankly due to the lack of wind here. However, wind energy is still more efficient where there is wind and more suitable to our winter peaking load pattern.

We have also heard from other members who want to be assured that their rates will not be paying for community solar. We have designed the program to not require cost shifting from one member to another at the distribution level.

We know the reasons for your interest in solar may vary. This project provides a good opportunity for those who want to either see solar grow for environmental reasons, for those who want the opportunity to participate without installing it in their own yard and for those who want to dabble in it and see how it goes. We have members who are passionate about solar, and we want to build this project and relationships with them. Although a few other Minnesota cooperatives have done similar projects, this is still very much in the learning stages.

For those who think they are going to save substantially on their electric bill, they may be disappointed. In our study, we increased the size from 40 kW to 80 kW to give the project a better opportunity for payback over the 20-year lease. We cannot tell you what the payback will be yet, as that is all dependent on what the future of our rates hold. We will try to provide some tools that you can use to make some projections, dependent on how much of an annual increase we will see in electric rates.

Elsewhere in this newsletter you will find more information to help you evaluate whether this program is for you. Contact our energy services department if you have additional questions.

In my annual report to the membership, I said we would have to be more innovative in the way we serve our members, realizing our members have many different interests. Here is an innovative project with hopes of more to come.

Northern Solar by Beltrami Electric Cooperative

n an effort to enhance renewable energy options for its members, Beltrami Electric Cooperative is launching a community solar project, Northern Solar.

Beltrami Electric has plans to construct an 80-kilowatt (kW) Direct Current (DC) solar array on the cooperative's headquarters property at 4111 Technology Drive in Bemidji. The array will consist of 192 photovoltaic (PV) panels rated at 400 watts each. A panel will produce more in the summer and less in the winter, with a projected annual average of 450 kWh based on the Solar Advisor Model from the US National Renewable Laboratory.

The solar equipment in Northern Solar will be a DUO PV System manufactured by tenKsolar, a solar technology company based in Bloomington, Minn. Though solar panels, often referred to as modules, get all the attention, there are a few other crucial components in the solar array. The unique design and properties of the tenKsolar module allow the DUO system to recapture any reflected light, even when it's coming from another module in the system. Inverters connect to the panels and convert solar energy from DC to AC that can be used in your home. A racking assembly will bring everything together, keeping the panels in place and stabilizing them against strong winds. Beltrami Electric personnel will prepare the site, install and interconnect the system.

For members considering a solar installation, participating in a community solar program may provide a more convenient, costeffective option in utilizing solar energy. The Northern Solar project allows any member to subscribe to the solar community program, and, in return, be allocated the energy produced by their subscribed panel(s) to offset their monthly electric bill.

Members who wish to subscribe to the Northern Solar project will pay \$1,295 for a full panel's output or \$647.50 for a half panel's output. Construction of the project is dependent on securing subscriptions for at least 50 percent of the solar array.

FREQUENTLY ASKED QUESTIONS

Do I have to be a Beltrami Electric member to participate?

Yes, to be eligible you must be a Beltrami Electric member in good standing with an active electric account.

What exactly am I subscribing to? Do I own part of the array?

You are not purchasing the physical equipment, but rather subscribing to a portion of the energy output of the solar array over 20 years.

How much does it cost to participate?

BEC members can subscribe for the output of a full panel for \$1,295 or half a panel for \$647.50.

What does this cost cover?

The cost of your panel(s) covers construction, installation and interconnection of the array. The cost also covers all maintenance and insurance expenses over the entire 20-year span of the license agreement.

What are the benefits of participating in community solar?

When you participate in community solar, you're choosing an alternative to fossil-fuel consumption. Solar energy is clean and abundant. Additionally, monthly credits will be calculated based on the current electric rate. That means if rates go up, the value you receive from your panel's production will too.

How much credit will I receive each month?

Your monthly credit will be calculated by dividing the entire array's total monthly production by the portion of the array that you've subscribed to. The resulting kWh credit will be applied to



your bill according to the current electric rate. One full panel is projected to provide a credit of 450 kWh per year based on the Solar Advisor Model from the US National Renewable Laboratory, depending on overall solar conditions.

Are there incentives available for participating in community solar?

Beltrami Electric is partnering with a taxable entity who can use the tax benefit, allowing the tax advantage to be passed on to the subscriber through a reduced panel price.

How much solar power can I purchase?

Residential members can purchase the equivalent of their lowest monthly energy usage with a maximum of six full panels. Commercial members can purchase the equivalent of their lowest monthly energy usage with a maximum of 10 full panels.

What if I move or no longer wish to participate?

In the event that you no longer wish to participate in community solar, you can gift or sell your subscription and credits to another BEC member.

How does community solar compare to installing solar panels on my home?

With Northern Solar, you don't have to worry about assembling or wiring your solar power - BEC will take care of that for you. BEC will handle all maintenance requirements during the 20-year lease. All you have to do to begin receiving solar power is purchase a subscription.

Is this solar array being subsidized by members of Beltrami Electric who are not interested in community solar?

No. This project is not subsidized by the entire membership. The costs associated with the solar array are paid for by those who enroll. In fact, Beltrami Electric's community solar reduces the cost shifting that typically occurs with net metered renewable generation.

How do I sign up?

Beltrami Electric members may enroll for community solar by calling the co-op's office at 218-444-2540 or toll-free at 800-955-6083. Upon indicating your desire to enroll in the Northern Solar project, the co-op will send you the contractual agreement for you to sign. A 10 percent deposit (refundable if the project isn't constructed) will be required to secure a panel. At least 50 percent of the panels must be subscribed to before equipment and construction will be secured.
