Reviewing budget/rates

2024 outlook

As I reported last month, your board of directors is in the process of reviewing the 2024 budget and rates. We expect wholesale power costs to remain flat in 2024, with a potential increase in 2025. Wholesale power makes up 70% of our total costs. Your board and employees worked diligently to control costs and we believe we may be able to keep rates steady in 2024. The board will take official action on the 2024 budget at its December board meeting (after this newsletter goes to print), but all indications are that rates will remain stable for yet another year. The last retail rate adjustment occurred in April 2018 nearly six years ago!

As a not-for-profit, member-owned cooperative, the only time we increase rates is when we absolutely must to satisfy our loan covenants and to keep your cooperative financially stable. We will continue to promote ways members can save on their energy bill through our conservation and efficiency programs.

Last month I also talked about the rising cost of materials and supplies over the last six years. I thought it would be good to expand on that topic this month and provide a bit more context in the article on page 3.

BOARD MEETING HIGHLIGHTS

Beltrami Electric Cooperative's board conducted its regular monthly meeting Wednesday, Nov. 29, 2023. A quorum of directors was in attendance.

The following reports were given at the meeting:

- President and CEO Echternach made his monthly report, including financials, budget, unclaimed capital credits, Operation Round Up® Trust Board, energy assistance vendor payment listing and large loads.
- Arlene Hogquist presented the financial report for October and discussed unclaimed capital credits.
- President and CEO Echternach and the Management team presented the 2024 Preliminary Budget.
- Mike Birkeland presented the 2024 Preliminary Marketing and Communications Plan.
- President and CEO Echternach discussed an amendment to the Beltrami Electric Cooperative Trust (Operation Round Up) bylaws and the recent board vacancy.
- Directors and President and CEO Echternach discussed upcoming meetings and education conferences.
- Director Mike Monsrud requested the board accept his resignation as a director of the Beltrami Electric Cooperative board as he no longer resides in District 3.

The following actions were taken at the meeting:

- · Approved the consent agenda.
- · Adopted a memorial resolution.
- Approved scholarships paid out of unclaimed capital credits.
- · Approved a year-end employee bonus.
- Approved a Beltrami Electric Cooperative Trust (Operation Round Up) bylaw revision to remove director term limits.
- Approved the Jan. 23, April 30 and Dec. 18, 2024 board meeting dates.
- Appointed Murl Nord as the Minnesota Rural Electric Association (MREA) voting delegate, Bob Wallner as the first alternate and John Lund as the second alternate.
- Appointed Sue Kringen as the CRC Annual Meeting voting delegate and Sharon Lembke as the alternate.
- Approved the director and President and CEO expenses.
- Accepted the resignation of District 3 director Mike Monsrud.
- Approved a motion to not appoint a director to fill the District 3 director vacancy and support the membership voting to fill the vacancy at the next annual meeting of the members as provided in the bylaws.

The next board meeting will be held Wednesday, Jan. 23, 2024.

NAVIGATING SUPPLY CHAIN CHALLENGES:

Beltrami Electric's commitment to affordability and reliability

Minding "the store" amid inflation pressures

The importance of planning and looking ahead is essential in Rich Riewer's job. As Beltrami Electric Cooperative's manager of engineering, Riewer knows it's more important than ever to keep an eye on the calendar – especially when it comes to ordering equipment and supplies for BEC's electric distribution system.

The challenge at hand

Riewer, with 26 years of experience in the industry, expresses concern about the unparalleled supply chain issues he's witnessing. "Prices for crucial components like spools of wire, underground cable, transformers, metering equipment, and even basic nuts and bolts have surged over the past few years. This poses a daily challenge in procuring co-op equipment vital for the safe distribution of electricity."

The roots of these challenges trace back to the COVID-19 pandemic, affecting not only BEC but industries worldwide. Core steel for transformers, heat shrink tubing, copper connectors and computer chips – all critical to the electric system's reliability – have experienced shortages and price hikes.

Adaptation and collaboration

To counteract these challenges, BEC has adjusted its approach. Riewer mentions, "We've adapted, ordered supplies earlier, and held some equipment longer in inventory to avoid construction delays. Our changes have helped shield us a bit from the continually



increasing costs."

BEC is part of a cooperative network, fostering relationships with equipment supply co-ops. Cooperative relationships are important in normal times – and even more so in extraordinary times because coops look out for each other – and co-ops look out for the members and communities they serve.

Matt Brandrup, CEO of RESCO, a co-op equipment supply company, highlights the industry's struggle with a 40% increase in product costs since 2020, putting pressure on members' capital expense budgets. "Inflation on the products we distribute has been at record highs over the past few years. In two short years, the costs of all the products we provide increased by 32% on average. While inflation has slowed in 2023, we expect to end the year with about an 8% product cost increase. That represents a 40% increase in product costs since 2020, which places a huge burden on our members' capital expense budgets."

Holding the line

Despite facing inflation rates of 14% in 2021 and an additional 18% in 2022, BEC remains dedicated to managing member resources carefully. The co-op has not implemented a rate increase in more than five years, emphasizing its commitment to providing excellent value to its members. As BEC navigates these turbulent waters, the cooperative's philosophy stands firm. It's a commitment to the members, ensuring that amidst supply chain challenges, the lights stay on, and the communities we serve receive dependable, affordable, and resilient electric service. This steadfast dedication will guide your cooperative into the New Year and beyond, promising a future of reliability and innovation.

Cooperatives are not-for-profit organizations that are member-owned and controlled. Profits made by co-ops are either reinvested in the co-op or returned to the members as capital credits or scholarships.

Beltrami Electric Cooperative and its board of directors are pleased to be able to award scholarships annually to deserving students attending seven area high schools in our service area. In addition, one \$2,000 At-Large Scholarship will be awarded annually to a student who does not attend one of the seven schools listed above.

Beltrami Electric Cooperative funds college scholarships with unclaimed capital credit dollars that, per Minnesota state law for unclaimed property, would otherwise be forfeited to the state. As a co-op, Beltrami Electric returns operating profit to members as capital credits. After attempts to locate the owner, uncashed capital credit checks become unclaimed property. When capital credits are unclaimed, these funds are used to offer scholarships for the children of co-op members.
