Operation Round Up°

Operation Round Up is just what its name implies. Each month, Beltrami Electric "rounds up" the electric bills of participating members to the next highest dollar. For example, a member's monthly bill of \$78.65 would be automatically rounded up to \$79, with the additional 35 cents going to Operation Round Up. Donations are tax deductible, and the average contribution per member is approximately 50 cents per month or \$6 per year. Members will receive an annual summary of their contributions on their January billing statement.

The Beltrami Electric Trust board administers Operation Round Up donations. The Trust board is made up of five members of our community who serve on a voluntary basis. The board will meet quarterly to review applications for grants and disburse the funds. This program's sole purpose is to improve the quality of life for our community. Through a cooperative and unified program, members will have a means of donating to worthy causes, and, through Operation Round Up, the small change of individuals can add up and make a big difference for our area. Together, we can do some wonderful things for our local communities.

Members who choose not to contribute to Operation Round Up can simply "opt out" of this voluntary program by notifying Beltrami Electric by phone, email or through our website.

Operation Round Up grant application forms available

Applications for the Beltrami Electric (Operation Round Up) Trust are now available. Grants will be awarded to nonprofit community-based organizations that demonstrate a commitment to enhancing the quality of life in our region. Projects should fit one or more of these categories: Community Service, Economic Development, Education & Youth and the Environment.

Grants will not be made for lobbying, political and religious organizations, veteran, fraternal and labor organizations, fundraising dinners, raffles, capital fund campaigns, national fund drives, advertising or ongoing operational expenses.

If your organization wishes to apply for Operation Round Up funds, grant application forms are available in our office or on our website at **www.beltramielectric.com**. The first application deadline is Sept. 30, 2016, and applications must be received at Beltrami Electric by 4:30 p.m. to be eligible. Funds will be disbursed in October.

Beltrami Rates Q & A

Why is Beltrami Electric (BEC) raising rates?

As a not-for-profit cooperative, we don't raise rates to generate profits. We raise rates to cover the cost of doing business and only when absolutely necessary. The price we pay for wholesale energy has increased by 8.3 percent over the past two years. Wholesale power costs make up almost 70 percent of the cooperative's expenses. That means 70 cents from every dollar collected pays for the energy and the transmission system required to deliver energy to our region, and only 30 cents covers how that energy is delivered to you. By working diligently to keep our costs down, the average rate increase to our members will be just under 5 percent.

How were the rates determined?

BEC employed an outside consulting firm to conduct a cost of service study, determine the cost of serving each group of members and work with the board and staff to develop rate design changes. Your board of directors is responsible for approving rates.

What is the access charge and why is it increasing?

The access charge is designed to recover Beltrami Electric's costs related to making a basic electric service available to all its members. According to the cost of service study, for many years BEC has been under-collecting on the monthly access charge. The study has indicated that the cost of having a minimum service available is more than \$40 per month. However, recognizing that increasing the access charge all at once would be difficult for many BEC members, the board approved changing the residential access charge to \$34.50 per month. This includes the cost of poles, wire, transformers, meters, right-of-way, etc., needed to provide the reliable electric system to serve our members.

Beltrami Electric serves an average of six members per mile of line, whereas utilities that serve cities and towns serve an average of 40+ customers per mile. Therefore, we as rural electric cooperative members each must share a greater portion of the investment and maintenance cost of the system required to provide service to our homes and businesses. A mile of single-phase line requires an investment of approximately \$75,000 to build, this plus annual maintenance expenses create a significant cost related to providing the grid access required to make electric services available to rural locations. The difference in access fees between rural and urban or an area with significant commercial customers often comes down to the number of customers or members sharing the fixed cost of each mile of electrical line.

What can I do to reduce my electric costs and can BEC provide any assistance in this area?

The most important thing you can do is practice conservation. By simply turning electrical equipment off or down, you can reduce your electric bill. Set your thermostat to 68 degrees or below in the winter and 78 degrees or higher in the summer; unplug electronic devices when not in use. BEC offers a number of options to help members manage their electric usage, including the web-based MyMeter program. Rebates are available for installing Energy Star® appliances, new electric water heaters, LED light bulbs, or new off-peak electric heating equipment. In addition, BEC's Demand Response (off-peak) system offers a significant savings to participating members compared to the standard electrical rate. TOP 10 TIPS FOR SAVING ENERGY AND MONEY


Below are the tips that any good energy saver should not live without. Make yourself a tip jar and put these 10 inside.

Top 10 Tips:

- 1. Plug electronic devices such as cable boxes, printers and TVs into power strips to turn off during vacations or long periods without use.
- 2. Replace any light bulb, especially ones that burn more than one hour per day, with a light-emitting diode (LED) bulb.
- Close shades and drapes during the day to help keep heat out in summer.
- Outside your home, caulk around all penetrations, including telephone, electrical, cable, gas, water spigots, dryer vents, etc.
- Set water heater temperature no higher than 120 degrees F.
- Use air-dry cycle instead of heat-dry cycle to dry dishes.
- 7. Keep your garage door down. A warmer garage in the winter and cooler garage in the summer will save energy.
- Change HVAC filters monthly.
- 9. Make sure the dryer vent hose is not kinked or clogged.
- 10. Ensure gaskets around door seal tightly.

Water heating is one of your home's largest energy expenses in most households, which makes it a smart area to try to improve efficiency. New electric water heaters are among the most efficient and durable products in the market today. With great new incentives from your cooperative, it has never been more affordable to upgrade.

All rebate-qualifying water heaters must be on the off-peak program/load management, which allows your water heater to draw electricity during times of low energy demand, such as late at night, when it is less expensive. The water heater is temporarily turned off during high demand periods, helping you save money on your monthly bill. Participants in the off-peak program receive a reduced kWh rate in exchange for allowing their water heaters to essentially be used as hot-water

Power plant tour

July 26-28, 2016

e are offering all Beltrami Electric members an exceptional summer opportunity that is fun for all ages. We are trying something new this year, as this year's tour will be three days, fitting more stops into one trip.

The tour is scheduled for Tuesday through Thursday, July 26-28. On the first day, we will tour Minnkota Power's control center and print shop in Grand Forks. From there we will make our way to Valley City, N.D., to see the Ashtabula Wind Center, where some of our wind energy is generated. The wind towers at Ashtabula are 250 feet tall with 120-foot blades. We will end our first day with a banquet dinner at the beautiful Baymont Inn & Suites in Mandan, N.D. We encourage you to bring your swimsuit if you'd like to enjoy the pool and water slide.

The second day we will visit the Milton R. Young Station near Center, N.D., where most of our electricity is

Weather permitting; this is also where we get to see the huge electric dragline Liberty up close, with its 300-foot boom and 70-cubic-yard bucket, which is used to remove the overburden soil from the coal. On the third day, we will take a guided tour of Fort Mandan and the Lewis & Clark Interpretive Center, at Washburn, N.D. After a stop in Carrington, N.D., for lunch, we will make our way back to Bemidji.

The cost to members for the three day trip is \$100 per person or \$175 per double occupancy, which covers the bus, hotel, tours and all meals.
