# Become a part of the Northern Solar Community today! New payment options available!

B eltrami Electric Cooperative plans to build an 80-kilowatt (kW) Direct Current (DC) community solar array at our headquarters. The array will consist of photovoltaic panels, each with a projected annual average output of 450 kWh. Northern Solar provides interested members an option to purchase renewable, locally-produced solar energy without the hassle of installing, permitting, maintaining and insuring their own solar array. Members may subscribe to as many panels as they wish, up to the equivalent of their annual average usage.

Members who wish to subscribe to Northern Solar will pay \$1,295 for a full panel's output or \$647.50 for a half panel's output. You can subscribe to panel(s) with a one-time upfront payment, or select a graduated payment schedule, with just 10 percent down, 40 percent due when the project breaks ground and the remaining 50 percent due upon completion of the project. Members will receive the energy produced by the panel(s) for 20 years as a monthly credit on their electric bill.

We have added a new financing option – Easy Pay – that allows members to select a 12, 24 or 36 month payment plan with no money down at 6 percent interest. The member will receive a monthly credit on their electric bill based on the portion of the array they have subscribed.

For members who don't wish to sign a 20-year contract, you now have the option to Pay As You Go. Simply tell us how many kWh/month you would like to come from Northern Solar and we will add it to your monthly electric bill. With no contract, you can cancel at any time.

Anyone who plans to dig is required by law to notify the state of their intentions at least 48 hours in advance.

All digging requires the 48-hour notification so that buried telephone line, television cable, pipelines, utility electrical lines, municipal water and sewer lines can be located to ensure that none will be severed or damaged.

## **Community solar, Co-op Month and** the seven Cooperative Principles

#### **Northern Solar**

Last year we announced plans for an 80-kilowatt (kW) community solar array to be constructed at our headquarters facility. Northern Solar will provide members with an opportunity to purchase the electrical output from a solar panel at a guaranteed rate for 20 years. A credit for the output of the panel will appear on the member's electric bill. Advantages of community solar over individual installations include cost certainty, no ongoing maintenance and insurance expenses and no structural assessment or issues in relation to installing panels on the roof of your home. Not to mention purchasing locally-produced energy with cutting edge solar technologies.

To date, members have subscribed to the output of 70 panels, but as initial interest has subsided, we've had a difficult time reaching the 50 percent subscription threshold to begin construction. What we have learned over the past year, and from other electric cooperatives who have implemented a community solar project, is that flexible payment plans and alternative pricing structures can lead to increased participation. That said, we have created a new pricing structure to include an Easy Pay financing option where members can pay for their subscription over 12, 24 or 36 months with no money down at 6 percent interest and still receive a credit on their bill for their incremental output of the solar array.

We've also added a Pay As You Go option where members can purchase locally-produced solar energy on a per kilowatt-hour (kWh) basis as an adder on their electric bill. The cost is \$.0503 per kWh and will appear as a line item on your electric bill. The advantage of this program is that it requires no money down and members can come in and out of the program as they choose.

We are optimistic that by providing these flexible options we will gain the commitment needed to construct the solar project.

#### **Cooperative Month**

October is one of my favorite months of

the year. The fall colors are exquisite, the air is fresh and outdoor opportunities abound. October is also Cooperative Month and I'd like to share with you the seven cooperative principles under which Beltrami Electric and cooperatives all over the world operate. I'd also like to share my local perspective of how we live out each of these principles on a daily basis.

#### **VOLUNTARY AND OPEN MEMBERSHIP**

Cooperatives are voluntary organizations open to all persons able to use their services and willing to accept the responsibilities of membership, without



gender, social, racial, political or religious discrimination.

Beltrami Electric exists to serve its members. If you come to us for electric service and agree to accept the responsibilities of membership, we will provide that service to you and we will deliver that service to the best of our ability.

#### DEMOCRATIC MEMBER CONTROL

Cooperatives are democratic organizations controlled by their members, who actively participate in setting policies and making decisions. The elected representatives are accountable to the membership. In primary cooperatives, members have equal voting rights (one member, one vote) and cooperatives at other levels are organized in a democratic manner.



Our members own this cooperative. Period. You elect the board of directors whose role is to set the strategic direction of your cooperative. They represent all of the member-owners. You have the option to run for the board of directors, to participate in your annual meeting and to take as much or as little interest in your cooperative as you desire. This is a very important, if not the most important, facet of the cooperative business model. Investor-Owned Utilities (IOUs) are regulated by a Public Utilities Commission. Cooperatives maintain their autonomy by being governed by their member-owners. This differentiator must not be forgotten and we must fight to protect and retain our local control.



# MEMBERS' ECONOMIC

Members contribute equitably to, and democratically control, the capital of their cooperative. At least part of that capital is usually the common property



of the cooperative. Members usually receive limited compensation, if any, on capital subscribed as a condition of membership. Members allocate surpluses for any or all of the following purposes: developing the cooperative, possibly by setting up reserves, part of which at least would be indivisible; benefiting members in proportion to their transactions with the cooperative; and supporting other activities approved by the membership.

Members participate by receiving and paying for electric service. The capital furnished by your economic participation is used to build and maintain the electric distribution system and to deliver energy and other services to the membership. As a not-for-profit cooperative, margins are allocated as patronage capital, used to reduce borrowing costs and then returned to the members as capital credits.



Cooperatives are autonomous, selfhelp organizations controlled by their members. If they enter into agreements with other organizations, including



governments, or raise capital from external sources, they do so on terms that ensure democratic control by their members and maintain their cooperative autonomy.

Our member-owners control their own destiny. Your cooperative was formed more than 75 years ago by a group of individuals who came together for the greater good. Your board of directors sets policy, rates and establishes the strategic direction of your organization. We are an independent, selfgoverned membership organization.



Cooperatives provide education and training for their members, elected representatives, managers and

employees so that they can contribute effectively to the development of their cooperatives. They inform the general public, particularly young people and opinion leaders, about the nature and benefits of cooperation.

Beltrami Electric promotes education and training of its members, board of directors and employees. We believe an educated and well-trained workforce can provide superior service to the membership. Education does not stop there, however. We will continue to educate our membership on the electric cooperative principles, legislative issues, energy efficiency, safety and technologies to help improve the quality of life for our rural communities.

# 6 COOPERATION AMONG COOPERATIVES

Cooperatives serve their members most effectively and strengthen the cooperative movement by working together through local, national, regional and international structures.

We work with other cooperatives to increase the value of your membership. We are members of not-for-profit supply cooperatives that allow us to receive better pricing on materials. We are members of financial cooperatives to reduce borrowing expenses. We seek assistance from area cooperatives during major storms and assist those cooperatives in their time of need. We utilize an after-hours dispatch service provided by a cooperative that knows how to treat our member-owners. We also partner with Paul Bunyan Communications through co-ownership of Cooperative Development, LLC.

#### CONCERN FOR COMMUNITY

While focusing on member needs, cooperatives work for the sustainable development of their communities through policies accepted by their members.



Beltrami Electric is committed to our local communities. Most of our members participate in a program called Operation Round Up, where members voluntarily round up their electric bill to the nearest whole dollar with those funds used to support community projects. Your cooperative also participates in economic development initiatives to spur growth in our communities, to create and retain employment opportunities and to expand service offerings to improve our quality of life.

These are just some of the examples of how we live the cooperative principles. As our founding members did more than 75 years ago, I encourage you to become active in your cooperative; to take an interest in its operation; to participate in the annual meeting and election process; and to fight to maintain our autonomy and independence.

#### Living the seventh Cooperative Principle

Last month we held the 12th annual Beltrami Electric Touchstone Energy<sup>®</sup> Open and raised more than \$8,000 for the United Way of the Bemidji Area. Over the past 11 years we have raised more than \$100,000 at this event to help our communities. I'd like to thank those who participated, our sponsors and our team of volunteers who

put on another successful event to benefit people in our community.

#### **Cooperatives Build Community**

The seventh cooperative principle is Concern for Community. Cooperatives work for the sustainable development of their communities through employee involvement in local organizations, through charitable contributions to community efforts and through support for schools.

# COLD WEATHER DISCONNECT RULE

#### 216B.097 COLD WEATHER RULE; COOPERATIVE OR MUNICIPAL UTILITY.

#### <u>Subdivision 1</u>. *Application*; notice to residential customer.

(a) A municipal utility or a cooperative electric association must not disconnect and must reconnect the utility service of a residential customer during the period between October 15 and April 15 if the disconnection affects the primary heat source for the residential unit and all of the following conditions are met:

(1) The household income of the customer is at or below 50 percent of the state median household income. A municipal utility or cooperative electric association utility may (i) verify income on forms it provides or (ii) obtain verification of income from the local energy assistance provider. A customer is deemed to meet the income requirements of this clause if the customer receives any form of public assistance, including energy assistance, that uses an income eligibility threshold set at or below 50 percent of the state median household income.

(2) A customer enters into and makes reasonably timely payments under a payment agreement that considers the financial resources of the household.

(3) A customer receives referrals to energy assistance, weatherization, conservation, or other programs likely to reduce the customer's energy bills.

(b) A municipal utility or a cooperative electric association must, between August 15 and October 15 each year, notify all residential customers of the provisions of this section.

#### Subdivision 2. Notice to residential customer facing disconnection.

Before disconnecting service to a residential customer during the period between October 15 and April 15, a municipal utility or cooperative electric association must provide the following information to a customer:

(1) a notice of proposed disconnection;

(2) a statement explaining the customer's rights and responsibilities;

- (3) a list of local energy assistance providers;
- (4) forms on which to declare inability to pay; and

(5) a statement explaining available time payment plans and other opportunities to secure continued utility service.

#### <u>Subdivision 3</u>. Restrictions if disconnection necessary.

(a) If a residential customer must be involuntarily disconnected between October 15 and April 15 for failure to comply with subdivision 1, the disconnection must not occur:

(1) on a Friday, unless the customer declines to enter into a payment agreement offered that day in person or via personal contact by telephone by a municipal utility or cooperative electric association;

(2) on a weekend, holiday, or the day before a holiday;

(3) when utility offices are closed; or

(4) after the close of business on a day when disconnection is permitted, unless a field representative of a municipal utility or cooperative electric association who is authorized to enter into a payment agreement, accept payment, and continue service, offers a payment agreement to the customer.

Further, the disconnection must not occur until at least 20 days after the notice required in subdivision 2 has been mailed to the customer or 15 days after the notice has been personally delivered to the customer.

(b) If a customer does not respond to a disconnection notice, the customer must not be disconnected until the utility investigates whether the residential unit is actually occupied. If the unit is found to be occupied, the utility must immediately inform the occupant of the provisions of this section. If the unit is unoccupied, the utility must give seven days' written notice of the proposed disconnection to the local energy assistance provider before making a disconnection.

(c) If, prior to disconnection, a customer appeals a notice of involuntary disconnection, as provided by the utility's established appeal procedure, the utility must not disconnect until the appeal is resolved.

#### <u>Subdivison 4</u>. Application to service limiters.

For the purposes of this section, "disconnection" includes a service or load limiter or any device that limits or interrupts electric service in any way.

## Beltrami Electric cold weather disconnect procedure

Per the Cold Weather Rule, Beltrami Electric Cooperative has a cold weather disconnect procedure in place. Our crews visit members who have not responded within 20 days of our mailed past due notice. Notices ask members to contact our office to create a payment arrangement and/ or pay their bill within 20 days of receipt, and a response by the member will prevent them from paying an additional \$50 for a collection fee/ occupancy check. Inability to make acceptable arrangements or payment will result in the disconnection of service after the 20-day period. ## **Penalty process**

<u>ALL</u> payments are due by the due date or penalty will be applied. (NOT POSTMARKED)

If you choose to pay by traditional mail, the payment MUST be received in our office by the due date. Please allow additional mail time to avoid a late fee **OR** visit our website at **www. beltramielectric.com** for more payment options.

# Attention military service personnel

Section 325E.028 of the Minnesota statutes pertaining to utility payment arrangements for military service personnel outlines their rights and responsibilities effective Aug. 1, 2007. A municipal utility, cooperative electric association or public utility must not disconnect the utility service of a residential customer if a member of the household has been issued orders into active duty, for deployment or for a permanent change in duty station during period of active duty, deployment or change in duty station if residential consumer meets criteria set forth in this statute.

If, prior to disconnection, a customer appeals a notice of involuntary disconnection, as provided by the utility's established appeal procedure, the utility must not disconnect until the appeal is resolved.

#### Beltrami Electric's Cold Weather Rule/ Military Service Personnel Appeal Procedure:

If you wish to appeal, submit a personal letter stating your situation and issues in the dispute to 4111 Technology Dr. NW, Bemidji, MN 56601. Your letter of appeal must arrive at the Cooperative **BEFORE** the date of disconnection. You will be notified when the board of directors will review your appeal so that you may be present during it. No disconnection of service will take place during the appeal process.

If you would like a copy of these policies or forms sent in the mail, please contact the office at 218-444-2540 or 800-955-6083. An application without copies of income statements and proof of military orders overseas will be considered incomplete, resulting in the possibility of no shut-off protection.

any other source for the largest period of time during the heating season. Members with an offpeak meter are only exempted sales tax on the electricity that is recorded on the off-peak meter.

Some buildings have both residential quarters and commercial operations. If there is one meter for the entire building, the exemption applies if more than 50 percent of the square
