Members benefit from upgrades to energy efficiency standards

After nearly four years of work, the **Energy Conservation and Optimization** (ECO) Act, a bill led by electric cooperatives, passed the legislature at the close of the regular session with strong bipartisan support and was signed into law by Gov. Walz. Thank you to Sen. Paul Utke for supporting significant and beneficial reform to the state's energy efficiency standards, a cornerstone of the state's energy policy.

Beltrami Electric Cooperative is excited about the improved benefits we will be able to pass along directly to our members because of the proactive provisions in the ECO Act.

The ECO Act gives Beltrami Electric more flexibility to recognize and respond to emerging technologies and consumer behaviors and demands. Utility programs that encouraged the adoption of technologies like LED lighting and Energy Star®-rated appliances have provided more than \$6 billion in net benefits to the state and supported local jobs in every corner of Minnesota. However, as new technologies have emerged, the Conservation Improvement Program (CIP) became outdated and needed reforms to continue providing tangible savings for energy consumers.

In addition to allowing utilities to

create programs that incentivize adoption and installation of new technologies to help reduce total energy use and save consumer-owners money, a groundbreaking reform around efficient fuel-switching substituting electricity or natural gas for a consumer-owner's current fuel source – is provided in the bill. As part of the reforms, efficient fuel-switching improvements will allow cooperatives to offer programs that substitute electricity for a member's current fuel when those programs achieve a trifecta of (1) reducing the overall amount of energy used; (2) reducing greenhouse gas emissions; and (3) reducing costs. The legislation also eliminates the state-mandated spending requirement, making the program a resultsfocused program rather than a spending program.

For more than eight decades, Beltrami Electric Cooperative has been providing members with safe, affordable and reliable electricity, and helping our members use energy wisely. The ECO Act will expand our efforts to help members save money and energy. At-large scholarship recipient




