
BELTRAMI ELECTRIC'S MITTEN TREE!

THE CEO'S REPORT

It's a Matter of (Co-op!) Principles

For me, this is a time of year for reflection and thanks, and topping my list of things I'm grateful for are the wonderful communities we serve. By investing in continuous learning for our employees and board members, our co-op is making a commitment not just to individual professional and personal growth, but to the future of the co-op and the high quality of service our members expect and deserve. It's a win-win situation.

We also strive to inform our members (that's you!) and the public about the mission and operations of the co-op. In fact, that's why you receive this magazine every month, so we can share the latest co-op news and updates, as well as energy efficiency and safety tips.

Cooperation Among Cooperatives

Member privacy – Red Flags Rule

As many as nine million Americans have their identities stolen each year. As a result of that startling statistic, the Federal Trade Commission has developed a regulation called the “Red Flags Rule.” The Red Flags Rule requires businesses to develop a program to detect, prevent and minimize the damage that could result from identity theft.

The data privacy of our members is important to us, and as a Beltrami Electric member, you may be asked to provide additional information and identification when you make inquiries on your account, such as verifying the last four digits of your social security number.

A member may complete an Authorized Contact Agreement form to allow us to give account information to others you want to have access to your account. This permits an Authorized Contact to make inquiries on the account to which they are authorized. The Authorized Contact must provide their name, date of birth and the last four digits of their social security number in order to receive account information. While these practices may seem intrusive, please understand that these procedures are in place to protect your member data and prevent the occurrence of identity theft.



AS PROPANE PRICES SPIKE, OFF-PEAK PROGRAM PROVIDES STABILITY

The last two years have shown consumers how volatile pricing can be – from gas to building supplies to vehicles. Most recently, propane prices have skyrocketed, leaving some people planning for a costly heating season. If you're looking for something rock solid, take advantage of an air-source heat pump on your co-op's off-peak electric heating program for your next system replacement or new home.

For the last decade, our low off-peak electricity price has remained stable, protecting you from the harsh, sometimes pocket-emptying cost swings of propane. With the off-peak electric program, you still have the choice to utilize a backup fuel source when it's very cold, and you have more control over your monthly expenses. It's the comfort and security you've been longing for.

What is the demand response – or "off-peak" – program?

The demand response program is voluntary for our members, and it has become a popular way to save on heating and cooling by reducing your exposure to variable propane prices. Participants allow our power supplier, Minnkota Power Cooperative, to remotely turn off electric heaters and other


interruptible loads in exchange for a discounted retail electric rate. This enables Minnkota to more effectively manage its existing power resources and avoid adding new, costly electric generating resources.

Save money with an air-source heat pump

Because of their advanced efficiency, the cost to run an air-source heat pump (ASHP) often falls well below the cost of propane-only heat. The difference grows when propane prices rise, which

can happen without much notice. Beltrami Electric offers hundreds of dollars in rebates to help offset the cost of installing a qualified ASHP.

In addition to protecting you from unpredictable fuel prices, ASHPs maintain the same comfort you expect without the need to endlessly monitor fuel levels. Electric heat doesn't run out, so you can avoid more seasonal refills and messy maintenance. Plus, less reliance on fossil fuels means fewer emissions inside and outside your home.

Give thanks for the off-peak program

This time of year, we often reflect on what we are thankful for and express gratitude for the good things in our lives. BEC is grateful for member-consumers who participate in the off-peak program. In true cooperative fashion, the program helps us all work together to use energy wisely, improve reliability of electric service and save money. The off-peak program is voluntary for consumers who agree to let Minnkota Power Cooperative, our wholesale power provider, temporarily interrupt power to certain electric loads when demand for electricity is high. Learn more below about how we all have something for which to be thankful with the off-peak program.

Member-consumers

Member-consumers like you receive a discounted electric rate (about half the retail rate) for participating in the off-peak electric heating, water heating or vehicle charging programs. In exchange for these savings, consumers voluntarily allow these electric systems and other interruptible loads to be temporarily turned off or switched to a backup fuel source primarily during periods of high demand for electricity. In addition to the lower electric rate, your cooperative offers numerous rebate and incentive programs to help offset the cost of purchasing new equipment.

Your cooperative

The cost of electricity is not only based on how much is used, but also when it is used. Your cooperative saves on its wholesale power costs through the off-peak program by reducing its demand for electricity during peak events. These savings are passed back to you through the lower off-peak rate.

Minnkota and the grid

By utilizing the off-peak program, Minnkota can more effectively manage its existing power resources and avoid purchasing high-priced energy from other utilities or the energy market. It also prevents the need to acquire or build new electric generating resources that would carry a very high cost.

The off-peak program proved extraordinarily valuable during the electric grid challenges experienced in February 2021, when widespread power outages and high market prices impacted other areas of the country. Minnkota and your electric cooperative were able to strategically use the program to shield you from price volatility and other system issues.



Is your dual fuel heating system ready for the winter season?

It's hard to believe winter is right around the corner. Since weather conditions and future wholesale power prices make the amount of load control hard to predict, we encourage all members with off-peak heating systems to have a reliable, automatic backup heating system in place and ready to use when needed.

TO ENSURE YOUR TOTAL COMFORT THIS WINTER, CONSIDER THE FOLLOWING QUESTIONS:

1. Is your backup heating system sized to heat your entire home or business and does it maintain an adequate comfort level? If not, consider upgrading.
2. Is your backup system propane/fuel oil? Be sure to fill your propane or fuel oil tank at the beginning of the season, and make sure your tank is large enough to hold an adequate supply. If your propane tank gets low during extreme cold temps, it may not work properly.
3. Is your backup system wood? Ensure you have an adequate

supply of firewood available and be ready to use it when needed.

4. Is your backup heating system working properly? Make sure to change your furnace filter regularly. Contact a heating/ventilation/air conditioning (HVAC) professional to inspect/maintain your system as needed.

RESIDENTIAL ELECTRIC HEAT SALES TAX EXEMPTION FORM

This is to certify that the main source of heat for my home (more than 50%) is furnished by permanently installed electric heating equipment (not portable) and I, therefore, am eligible for the electric heating sales tax exemption as provided by Minnesota Sales Tax Fact Sheet 157. This exemption is for the billing months of November through April only. **Exemption forms should be resubmitted every 3-4 years. Please notify us if you change from electric heat to a different primary heat source.*

Electricity sold for residential use is not taxable for the billing months of November through April when sold to metered members who use electric heat as their primary source of residential heat. If more than one type of heat is used, electricity is not taxable if electric is the primary source of heat. Primary source of residential heat is the source that supplied more heat than any other source for the largest period of time during the heating season. Members with an off-peak meter are only exempted sales tax on the electricity that is recorded on the off-peak meter.

Some buildings have both residential quarters and commercial operations. If there is one meter for the entire

building, the exemption applies if more than 50% of the square footage of the building is residential.

Complete and submit the above form only if you are eligible for the exemption. If you have more than one account, an exemption form must be filed with each location. The state of Minnesota recommends the exemption forms should be updated and resubmitted every three to four years to be eligible for the exemption. Members who receive a tax exemption when electric heat is not their primary source of heat are in violation of the sales tax law.

The actual date daily cycling begins varies each season. Thermal storage heating is controlled each day from 7 a.m. to noon and 5 p.m. to 11 p.m.

OPERATION ROUND UP® HELPS LOCAL PROGRAMS

The Beltrami Electric Cooperative Trust board met in October to review Operation Round Up® grant applications, which it received requesting funding for various local programs. The total amount requested this quarter was \$51,319. The board awarded grants to 18 area nonprofit and community organizations totaling \$43,222.

Many local programs and organizations benefit from Operation Round Up, a voluntary, member-driven fundraising program of Beltrami Electric Cooperative, designed to give members a means of working together to use their small change to make a big impact in our local communities. Together, we are doing some wonderful things for our friends and neighbors.

All funds for Operation Round Up are placed into a trust fund that is separate from electric accounts. The trust is administered by its own board of directors, comprised of five volunteers from our communities, who meet twice a year and decide if an application meets the guidelines of the program and if funds are available. The average amount a participating member will contribute is 50 cents a month or \$6 a year, while the maximum annual contribution possible is \$11.88 per year. Contributions to Operation Round Up are tax deductible and will be shown on your billing statement.
