Great River Rescue's mission is to transition dogs and cats to loving homes, serve as a community resource and advocate for kind, responsible pet care.



Beltrami Electric Cooperative named Great River Rescue of Bemidji as the winner of the local 2022 Touchstone Energy® Community Award.

"Great River Rescue clearly demonstrates a strong commitment to community that we at Beltrami Electric value highly," Communications Specialist Angela Lyseng said. "We are very pleased to recognize Great River Rescue's contributions to our local communities."

Great River Rescue is a community-funded and supported nonprofit organization that is committed to finding stable homes for animals in northern Minnesota. They are a no-kill animal shelter that operates in Bemidji and provides numerous services in Bemidji and surrounding areas, as well as collaborating with other animal welfare organizations across the state. Great



resources to provide care and service to more than 350 stray

and surrendered animals each year that are brought to the shelter by members of the public, the city of Bemidji and Beltrami County.

Their Pet Fixers Clinics allow low-income families and others in financial distress a way to spay, neuter and vaccinate their pets at below-market rates. Great River Rescue also partners with other animal welfare agencies such as Red Lake Rosie's Rescue to offer spay/neuter and wellness services to the broader community.

Rate stability

High inflation, aggressive interest rate hikes, material costs and lead times higher and longer than they've ever been have posed tremendous challenges to businesses within every industry. Your board of directors approved the 2023 budget in December with no rate increase planned for 2023. This is the FIFTH consecutive year rates have remained stable. Your board and employees undertook an intensive strategic planning process this fall and at its December meeting your board approved a new three-year strategic plan focused on four core areas:

- *Growth Promote Growth* that Provides Value to Members

Your cooperative had another solid year in 2022. We finished the year financially sound with sufficient margins to meet all of our financial obligations and loan covenants. We completed the second year of our fouryear construction work plan, including projects near Guthrie and Cass Lake, Wildwood Rd., Hillcrest Dr., Sunny Beach Rd., and Sunset Cove. Line crews also constructed nearly 300 new



services and performed nearly 70 service improvements for our membership.

We avoided major storms in 2022 and our service reliability remains excellent. Our crews did an outstanding job restoring power safely and efficiently when outages did occur. Most importantly we completed all of this work safely.

I'm very proud of our employees for all they accomplished in 2022 and for their dedication to serving our members, safely and efficiently.

Customers include major corporations from the aerospace, electronics, medical and food industries.

Energy conservation, the environment and alternative energy sources are also important to Wells Technology as its business grows. Therefore, Wells Technology designed and manufactured a unique solar tracking system for solar panels to follow the sun's daily movement, even in the coldest -40°F days. This innovative solar system was installed with the help of electricians, engineers and inspectors. A field of these large 2-axis solar trackers, along with electrical power from the Beltrami Electric grid, provide the additional electrical energy required for annual growth in manufacturing at Wells Technology.

In addition to Wells Technology, Andy Wells also founded Wells Academy, which strives to help Native American people by providing apprenticeship programs in employment-challenged areas. Wells Academy offers Native American students career training and opportunities in computers, machining, engineering, inspecting, packaging and marketing for American industry.

NEW FEDERAL ENERGY INCENTIVES TO ROLL OUT IN 2023

When Congress passed the Inflation Reduction Act (IRA) in 2022, it authorized billions of dollars in consumer programs to help install energy efficient technologies, purchase an electric vehicle or electrify other processes in your home. The average homeowner could qualify for more than \$10,000 in tax credits or other incentives, which means there's no better time to start planning for energy upgrades.

WHAT YOU NEED TO KNOW

Most of these programs will not be implemented until sometime in 2023. Once the programs kick in, most will last at least 10 years.

6 UPCOMING INCENTIVES TO CONSIDER*

HEAT PUMPS

There are massive incentives for households to install air-source heat pumps. Up to \$8,000 in upfront discounts and up to \$2,000 in tax credits are available. Geothermal heat pumps qualify for a 30% tax credit.



WEATHERIZATION

Weatherization efforts may qualify for up to \$1,600 in upfront discounts and \$1,200 in tax credits depending on income. This includes air sealing, ventilation and upgrades to insulation, doors and windows.



ELECTRIC PANEL

Upgrading your electrical panel (sometimes called breaker box) could qualify for up to \$4,000 in upfront discounts and up to \$600 in tax credits depending on income levels.



ELECTRIC WIRING

Electric wiring upgrades could qualify for up to \$2,500 in upfront discounts depending on income levels.



ELECTRIC VEHICLE

Thinking of purchasing an electric vehicle (EV)? You may qualify for up to \$7,500 in tax credits for a new EV, or up to \$4,000 for a used EV.



ELECTRIC STOVE

Up to \$840 is available for the purchase and installation of an electric stove.



WHAT DOES OFF-PEAK MEAN? Let's Ask Bob!

Technically, it means the cost of electricity is at its lowest when the use of electricity is at its lowest - an example would be nighttime hours when you've turned down the heat, most of the lights are off and very few appliances are operating

- or at least not as many as you might use around suppertime.

Practically speaking, off-peak is a great way for members to save money on electric bills. Our off-peak winter rate is 6.7 cents per kWh. That's about half the general service electric rate, and about two-thirds the cost of other heating fuels right now. Off-peak is good for your pocketbook and for keeping your home warm and comfortable.

Said another way: Off-peak = value, comfort, convenience and the benefits of choice so that members can choose the lowest-cost heating option each winter. With fuel prices the way they are right now - it's hard to beat off-peak.
