<b>Requirements:</b> <ul style="list-style-type: none"> <li>Equipment must be new and installed in a residence served by Beltrami Electric Cooperative, Inc. by December 31, 2025.</li> <li>Electric heating equipment must be on BEC's load management system with a qualified backup heat source. Air source and geothermal heat pumps are exempt from this requirement.</li> <li>Electric heating equipment must be the primary source and properly sized to heat the building.</li> <li>Electric heating equipment must be hard-wired (no plug-in loads eligible for rebate).</li> <li>If the potential incentive is greater than \$5,000 contact BEC to get pre-approval.</li> <li>A copy of the itemized invoice is required for all rebates. Invoices dated over one year will not be accepted.</li> <li>Must be installed by a qualified, insured contractor or inspected by Beltrami Electric.</li> <li>Electric heat backing up a geothermal system must be on BEC's load management system to receive a geothermal rebate.
